2015 MARCHING GROUP RULES

A. GENERAL RULES:

- 1. Marching Groups (and all organizations within a Cluster Group) must be federal 501(c)(3) tax exempt organizations and may not be paired in any manner with a 501(c)(4) organization. All returning organizations' information is on file with the Parade. Each new organization must submit its official documentation (Certificate of Incorporation, IRS letter, mission statement, etc.). The Parade reserves the right to reject any registration or revoke any approved registration.
- 2. All Groups must identify with Israel as a Jewish and democratic state and recognize Israel as the homeland of the Jewish People.
- 3. All Groups must oppose, not fund, nor advocate for the Boycott, Divestment and Sanctions (BDS) movement against Israel, which seeks to delegitimize the State of Israel by not recognizing it as a Jewish state.

B. GROUP RULES

- 1. The number of participants in a Marching Group **must be no fewer than 60**. Organizations with fewer than 60 participants may register as part of a Cluster Group.
- 2. Only students who are 4th grade and above may march. Only adults affiliated with educational or youth organizations are permitted to march with such groups.
- 3. Jewish/Zionist Youth organizations must be affiliated with either the American Zionist Movement or a major Jewish religious movement such as Orthodox, Conservative, Reform or Reconstructionist.
- 4. All groups must assign at least two liaisons to attend the mandatory Parade Creative Planning Meeting as part of the registration process.
- 5. All Marching Group participants children and adults **must wear coordinated attire**.

C. PARADE DAY RULES

1. All Groups must have the following for the Parade: a) An Organization Name Banner; b) a Theme Statement Opening Banner; c) Hand-held props; and d) uniformity of costume/attire/t-shirts.



- 2. The Parade shall approve all banners, props, flags, music, T-shirts and costumes used in the Parade. Groups **may not**, under any circumstances, insert new banners, additional statements on banners or other props unrelated to their approved theme (e.g. political slogans, divisive or inflammatory statements). No weapons or representations of weapons are permitted.
- 3. Only registered Groups and approved vehicles are allowed to participate in the Parade. **No spectator nor an unapproved vehicle may join the Line-of-March at any time or anywhere.**
- 4. Participants **must** walk the full length of the Parade route and are not allowed to leave the Line-of-March at any time, including the VIP seating area. All Groups **must** move forward at all times unless directed to stop by the NYPD and/or Parade Staff.
- 5. Strollers and carriages as well as talking on cell phones are strongly discouraged.

Tone & Spirit Agreement and Release

The Celebrate Israel Parade is a pageant-like event whose sole purpose is to demonstrate the community's love for the Jewish and democratic state of Israel. It is held with pride and with a sense of unity, despite philosophical or political differences within the community-at-large.

- Themes and Creative Visual Presentations must be in the tone and spirit of the Parade.
- Registered Marching Groups must present their theme statements and messages on JCRC-NY approved banners and props in optimistic, inspirational and positive phraseology.
- ♦ The Parade is an apolitical event. It is not a rally, a protest march, nor a walk-a-thon.
- **1.** We have read the Rules of the Parade; and, as a participating Marching Group, we agree to adhere to them. We understand the Parade's requirements as to the Tone & Spirit of the Parade; and, as a participating Marching Group, we agree to adhere to those directives.
- **2.** We understand that any infraction of the aforementioned, either prior to the Parade or on Parade Day, constitutes grounds for probationary status, denied participation and/or removal, by Parade Staff or City Officials, of any and all offending articles, banners, props, etc. from the Parade route that are political and controversial.
- **3.** We understand that, should our Marching Group be denied entry in the Parade, or should our participation be cancelled due to violation of the above directives, the Parade shall not return our registration fee.
- **4.** We hereby grant permission, without reservation, to the Jewish Community Relations Council of New York, Inc. ("JCRC-NY"), and those authorized by JCRC-NY, to take photographs and to make video and/or audio recordings of our Marching Group and all its participants at the Parade, and to use them in original or modified form in all media now or hereafter known, with or without our Marching Group's name or name of any participant, for the promotion, public education, and/or fundraising activities of JCRC-NY. We understand and agree that there will be no compensation for the above and agree that JCRC-NY will be the sole owner of all tangible and intangible rights in the above-mentioned photographs and recordings, with full power of disposition.
